

**MEMORANDUM OF ASSOCIATION OF ALUMNI OF RANCHI
AGRICULTURAL COLLEGE/BIRSA AGRIL. UNIVERSITY**

1. The name of the Society shall be "ALUMNI OF RANCHI AGRICULTURAL COLLEGE(A.R.A.C).
2. The registered office of the Society shall be situated at Ranchi Agricultural College campus under the Birsa Agricultural University, Kanke, Ranchi, Jharkhand.
3. **Object of the Society:** To inculcate a sense of belongingness towards the Institution amongst the passed-out students who obtained Degree from Ranchi Agricultural College/Birsa Agricultural University in any of the branches of Agriculture science, by promoting such activities like:-
 - (i) a) Preparation of Directory of their career and growth after passing out and publication thereof;
 - b) To keep in touch with them on a continuing basis;
 - c) To arrange for get-together of Alumni members with their spouses at least once in a year; and,
 - d) To bring about publications containing papers/articles contributed by the Alumni members and through that to harness and share their valuable experiences in the field of agricultural development , forestry, business, banking, administration, management fine-arts etc.
- (ii) To promote positive activities for the students of Ranchi Agricultural College/Birsa Agricultural University through grant of Scholarship to Meritorious/Poor/Deserving students and to help in promoting appropriate workshop, interface sessions, lecture, debates, cultural activities etc. for their personality development.
- (iii) To receive and collect any gift, subscription and donation either in cash or in kind and acquisition thereof by any lawful ways and means and to spend the same in fulfillment of all or any of the aims and objects of the Society provided that if any donor intends that his donation shall be applied to the attainment of any particular object of the Society then that donation shall be accordingly earmarked for the promotion of that object only.
- (iv) To acquire by purchase, take on lease, hire or by gift or otherwise and hold valuables/immovable properties or any right or privilege that may be deemed necessary or useful for the promotion/advancement of the objects of the Society or any of them.
- (v) To do all such lawful acts, deeds and things as are incidental or conducive to the attainment of the objectives or part thereof.
- (vi) To arrange collection of Agricultural problems – technical, social, area specific, and individual or institutional in the State of Jharkhand and to provide solutions through advisory function of the same and also to disseminate technical know-how.

4. Without prejudice to the generality of the above objects and for effectively carrying out the same, the Society shall have power to receive, hold and possess any property including security of any kind and to construct and maintain any building, to arrange transfer or otherwise dispose of or deal in any property or security and to enter into contract for or in connection with the purposes of the Society, and to raise money and funds for the fulfillment of its objectives.

5. The management and control of the Society shall be in the hands of its Executive Committee to be elected annually in the Annual General Meeting and shall be carried on accordance with the Rules and Regulations as may be framed or notified by the said Executive Committee whose names, addresses and descriptions are subscribed hereunder:
